A RESOLUTION RECOMMENDING ADOPTION OF THE PROGRAMS, PROJECTS & ACTIVITIES OF ALL THEMATIC PLANS FY 2020 OF BARANGAY ANOLING, PINAMALAYAN ORIENTAL MINDORO REQUESTING FUNDS FOR IMPLEMENTATION AND TO BE INTEGRATED TO AIP 2020;

WHEREAS, Local Budget Mem 280 mandates LGU budgets to aalocate at least 5% of its budget to gender related PPAs that benefit women especially those from marginalized sector even in the light of economic and fiscal crisis and austerity measures of the national government;

WHEREAS, Section 21 of RA 10121 Rule 18 of its IRR and item 4 of NDRRMC-DBM-DILG JMC No.2013-1 dated march 252013 not less less than 5% of the estimated budget revenue of all LGU from regular sources shall set aside as the LDRRMF and shall be utilized in accordance with the pertinent provision of laws, and regulations;

WHEREAS; Section 3 of Executive Order No.366 Series of 1996 the BPOC shall formulate plans and recommended such measures which will improve or enhance peace and order and public safety in their area of jurisdiction;

WHEREAS: all LGU are encouraged to provide funds in their annual budget for the conduct of drug clearing operation ,establishment of Special drug Education center and strengthening of the criminal justice system;

WHEREAS: DILG MC No. 2018-42 March 26,2018 all LGU are enjoined to prioritize in the allocation of local funds the PPAs included in their Local Nutrition Action Plan, which shall be formulated in accordance w/ the Philippine plan of Action for Nutrition 2017-2022;

WHEREAS; Pursuant to RA9344 of the Juvinile Justice and Welfare Act of 2006 Section 15 all LGU shall allocate 1% of their IRA for the strengthening the implementation of programs projects and activities of LCPC;

**NOW THEREFORE**, on motion of Kgd. Gerry L. Agbay , duly seconded by Kgd. Randy H. Moredo , BE IT RESOLVED as it hereby resolved to adopt the programs ,projects, and activities of all thematic plans FY 2020 of Barangay Anoling Pinamalayan Oriental Mindoro requesting funds for implementation and to be integrated to Annual Investment FY 2020

RESOLVED FURTHER, that copies of this resolution be forwarded to the Barangay Development Council & Sangguniang Barangay of Barangay Anoling Pinamalayan Oriental Mindoro for its review and approval;
