**WHEREAS**, Section 21 of RA 10121 Rule 8 of its IRR and item 4 of NDRRMC-DBM-DILG JMC No.2013-1 dated March 25,2013 all LGU shall allocate not less than 5% of the estimated budget Revenue from regular sources shall set aside as the LDRRMF and shall be utilized in accordance with the pertinent provision of laws, and regulation ;

**WHEREAS**, Section 3 of Executive Order No.366 series of 1996 the BPOC shall formulate plans and recommended such measures which improve or enhance peace and order and public safety in their area of jurisdiction;

**WHEREAS** , all LGU are encourage to provide funds in their annual budget for the conduct of drug clearing operation ,establishment of special drug education center and strengthening of the criminal justice system;

**WHEREAS**, DILG MC No.2018-42 dated March 26,2018 all LGU are enjoined to prioritize in the allocation of local funds the PPAs included in their Local Nutrition Action Plan ,which shall be formulated in accordance w/ the Philippine Plan of Action for Nutrition 2017-2022;

**WHEREAS**, Republic Act 9003 dated January 26,2001 Section 2 hereby declared that it is a policy of the state to adopt a systematic ,comprehensive and ecological solid waste management program which shall ensure the protection of public health and environment;

**WHEREAS**, all government procurement shall be undertaken in accordance with agencies duly approved by its agency head;

**WHEREAS**, the State shall promote public awareness about the causes, modes of transmission, consequences, means of prevention and control of HIV/AIDS through a comprehensive nationwide educational and information campaign organized and conducted by the State;




